

MINUTES OF CONDEMNATON COMMITTEE MITTING HELD ON 30/09/2022

Venue: Department of Radiodiagnosis

Dr. A.T.Tayade (Chairman) welcomed the members of Condemnation Committee. Proposals from 15 Departments/Wards were received. These proposals for items/instruments/material in Annexure -1 were placed before the committee for decision regarding condemnation. The list is as follows. 1) Dean Office 2) Anesthesia Dept. (Main OT), 3) Pediatrics NICU Ward, 4) Male Surgery Ward-2 & Private Surgery Ward, 5) Neurosurgery OT, 6) Surgery OT, 7) Ophthalmology OT, 8) Orthopedics OT, 9) ENT OT, 10) Male Ortho Ward, 11) Dept. Of ENT, 12) Dept. of FMT - A & B, 13) Kasturba Nursing College, 14) Casualty, 15) Dept. of Anatomy.

The proposals of Condemnation items and equipment which were unserviceable/not in used or defunct prepared by various departments were forwarded by Secretary KHS/Dean MGIMS/Medical Superintendent, Kasturba Hospital to condemnation committee for further necessary action.

In the meeting discussion was mainly on,

Dr. Tayade (Chairman) discussed about the some suggestion for amendment of guidelines
of condemnation which were submitted to the Hon'ble Secretary of KHS after last
condemnation committee meeting held on 06/08/2021. Till date, no guidelines received
to the condemnation committee from the Hon'ble Secretary, KHS.

Mr. Kolhe (I/C Eng. Section) said that we should have new SOPs of condemnation. Dr. Tayade (chairman) said that already he had discussed with Dean, MGIMS and Hon'ble Secretary KHS. We are expecting the new guidelines and SOPs from competent authority of KHS in future.

2) Dr. Tayade(Chairman) pointed out that, some proposals of items costing more than Rs. 20,000/- were certified by our Biomedical Engineer KHS. As per the present guidelines, Biomedical Engineer KHS has authority to certify the items below Rs. 20,000/-(INR, Twenty Thousand). Hence it was decided unanimously by all committee members not approved the items costing more than Rs. 20,000/- which were certify by Biomedical Engineer KHS. Beyond this cost certificate from concerned company should be

mandatory. In case company from whom the instrument was purchase was shut down than requested for condemnation should be supported by

- A) Certificate from HOD stating that the said company from whom instrument was purchase has shut down and Certificates from at least two authorized service engineers certifying the status of instrument.
- 3) Committee members discussed regarding the non-serviceable date for condemnation of items. The committee members concluded that, the date of certificate issued by concerned company or competent authority should be considered.
- 4) Committee members discussed proposals received from Kasturba Nursing College for condemnation. Mr. Kolhe (I/C Eng. Section) told that Kasturba Nursing College is nongranted college and should not be considered for the condemnation. Dr. Tayade (Chairman) said that, he will discussed this matter with Dean, MGIMS, Sewagram. (Dean had said that the condemnation committee is constituted for institute. Hence the proposal of Kasturba Nursing College should be return back).
- 5) Department of Anatomy submitted the proposals for condemnation in which the item C24 High speed Cooling Centrifuge machine which having the cost 1,33,774/-. Mr. Kolhe (I/C Eng. Section) said that I had given only inspection report of item C24 High speed cooling machine and not the condemnation certificate. Mr. Kolhe (I/C Eng. Section) told that the condemn certificate should be obtain from the concerned company for condemnation.
- 6) Department of Forensic medicine submitted the proposals for condemnation in which the item Mortuary Cold Storage Cabinet-2 Bodies, of costing Rs. 3,20000/- which having date of purchase 02/08/2017 and date of non-serviceable is 03/12/2020. The duration of working items is 3 years 4 month and the committee member told that the working period of item should be at least 5 years. The condemnation certificate issued by Shree Enterprises, Nagpur dated 05/01/2022 is not sign by concerned company. Hence it was decided unanimously by all members, the proposals should be return back and the said items is not approved for condemnation in this meeting.
- 7) The committee was of the opinion that, as items which were unrepairable or not upgradable should be condemned and procurement of scrap amount should be done by appropriate authority of KHS. The committee was also of the opinion that as item which were unrepairable and inability to procure the scrap amount for these should be disposed. Disposal should be done by the appropriate authority of KHS according to the recommendation of Maharashtra Pollution Control Board and Civic body.
