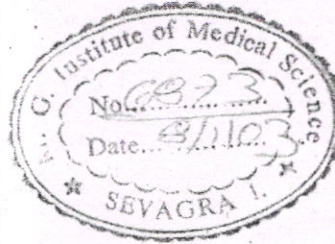

I am to state that the General Body of the Council at its meeting held on 20th & 21st Nov., 2002 considered the compliance verification report (September, 2001) together with compliance and Council Inspector's report (April, 98) on the standard of examination and other teaching facilities available at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha for purpose of approval of the college for the award of M.S.(General Surgery) qualification granted by Nagpur University.
