I am to state that the General Body of the Council at its meeting held on 14.2.2001 considered the Council Inspector's report (November, 2000) on the standard of examination and other teaching facilities available at Mahatma Gandhi Institute of Medical Sciences, Sewagram, Wardha for purpose of approval of the college for the award of M.D.(Obst. & Gynae.) and D.G.O. qualifications granted by Nagpur University.
