I am to state that the General Body of this council at its meeting held on 15.03.2008 considered the Council Inspector's report (December, 2007) on the standard of examination and other teaching facilities available at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha for purpose of recognition of DOMS/DO qualification earlier granted by Nagpur University and now by Rashtra Sant Tukdoji Maharaj Nagpur University and the Council approved the following recommendations of the Postgraduate Committee:-

"The Postgraduate Committee considered the Council Inspector's report (December, 2007) and decided to recommend that DOMS/DO qualification earlier granted by Nagpur University and now by Rashtra Sant Tukdoji Maharaj Nagpur University in respect of students being trained at Mahatma Gandhi Instt. of Medical Sciences, Sewagram, Wardha be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee further decided to direct the institution authorities prospectively to restrict the number of admission to 1 (one) student per year."

You are therefore requested to notify the above qualification at the earliest.
